Don't Forget Ambrosia Beetles Just Yet

Last Friday we were still catching granulate ambrosia beetles in traps in central eastern NC. Fluctuating temperatures have resulted an a sporadic season of activity. First emergence came as early as February 10 in some areas. There was no activity in the traps I was monitoring in March. April was a little more consistent. Every year and area is different and thus important for anyone that has issues with this insect to trap at their nursery.

GDD from across the region:

Wilmington area: 825-850 Fayetteville area: 750-800 Greenville area: 650-675 Smithfield area: 575-600 Rocky Mount-Wilson area: 575-600 South Wake County area: 550-575

I have installed 3 trials targeting larvae this spring. 2 are focused on drench or topdress pretreatments before egg hatch. They were treated about a month ago. I have begun harvest of those trials. The last one was treated a week ago targeting hatched larvae with contact products and harvest will begin later this week or early next week.

I have not gotten any reports yet, but adults should be out in the southern Counties by now (Wilmington area at least and possibly up to Fayetteville). Please send me an email or text when you have adult emergence so I can track progress.

Potato Leaf Hoppers on Red Maples

I have not gotten yellow sticky cards out yet but I am getting cards to Sam Marshall, Brunswick County Horticulture Agent, early this week to start monitoring in the southern part of our region. Last year we had a significant increase in population around May 15 but each year is different. As soon as we get some on traps I will spread the word.

If left untreated, saliva injection during feeding results in hopperburn on maples that looks like a foliar burn, witches' broom, or anthracnose. After leaf hoppers arrive applications of pyrethroid insecticides every two weeks are necessary to prevent damage which will need to continue until frost. Up to 10 - 12 applications may be necessary. If your nursery has repeated injury from this insect you might consider application of a neonicotinoid drench before leaf hopper arrival in the future to prevent damage for two growing seasons.
