Nursery Insect Trapping



I will be presenting at Green & Growin' on Tuesday, January 15 at 9:30 am during the "In the Dirt" education track. The presentation will focus on how a scouting program is an important part of a

total Integrated Pest Management Program. The session will cover various trapping

techniques in nursery settings and will focus on granulate ambrosia beetle, potato leaf hopper, red headed flea beetle, scales, and European pepper moth as examples of trapping programs. I look forward to seeing everyone in Greensboro.

Spotted Lanternfly

The spotted lanternfly, *Lycorma delicatula*, is a large plant hopper that as an adult is almost an inch long. This invasive pest is native to Northern China and was discovered in Pennsylvania in 2014. It has a wide host range and does overwinter as eggs so you would not see them in January. First nymphs hatch in spring and adults develop in summer in Pennsylvania.

The host list of this insect is around 67 plant species in Korea where it first became invasive. It is a pest of grapes, stone fruits like apples, willow, and many hardwood tree species. This insect was found in Frederick County in northern Virginia in early 2018. To my knowledge it has not established in Virginia or moved farther south at the time I am writing this.

This insect has not been reported in North Carolina. However, the North Carolina Department of Agriculture is on the lookout for it. To protect NC Agriculture it is important to report this insect if discovered. If you see an insect that appears similar report it to the NC Department of Agriculture or your local NC Cooperative Extension office. I have included a link to the Pest Watch fact sheet below from the NC Department of Agriculture which includes images of various life stages to help with identification and contact information.
